FSSAI Proposes Adoption of 46 BIS Standards for Food Additives

Report Highlights:

The Government of India's (GOI) Food Safety and Standards Authority of India (FSSAI) published a draft amendment relating to adoption of 46 Bureau of Indian Standards (BIS) for food additives. The GOI will accept comments from the World Trade Organization (WTO) trading partners for 60 days beyond the notification date as listed on the WTO's website (<u>www.wto.org</u>).

On June 29, 2016, FSSAI published a draft amendment relating to adoption of 46 BIS for various food additives, on its website. The draft amendment was notified to the WTO member countries and comments invited. The comment period for trading partners expires 60 days from the date it is notified on WTO website (<u>www.wto.org</u>).

Amendments relate to the following from the Food Safety and Standards (Food Product Standards and Food Additives) Regulations, 2011. It is recommended that interested parties should thoroughly review the notification for major revisions.

- 1. A new clause to include the standards on Beta-apo-8-carotenal, ethylester of Beta-apo-8-carotenoic acid, Titanium dioxide has been added.
- 2. New sub-Regulations have been added and the list is given below.

3.2.9 – Preservatives and their standards(Sodium Benzoate/Benzoic Acid/Potassium Nitrate/Sorbic Acid/Potassium Nitrate/Sodium Propionate/Sulphur dioxide)
3.2.10 – Acidity Regulator and their standards (Ammonium hydrogen carbonate/sodium citrate/fumaric acid/tartaric acid/dicalcium phosphate/phosphoric acid/citric acid/malic acid/sodium hydroxide)

3.2.11 – Gelling agent/thickener/stabilizer and their standards (Sodium alginate/sodium carboxymethyl cellulose, enzyme hydrolysed/agar/gum Arabic/tragacanth gum/ghum ghatti/calcium alginate/alginic acid/guar gum/gum karaya/polyglycerol esters of fatty acids/polyglycerol ester of interesterified ricinoleic acid/glycerol esters of wood rosin/pectin/carrageenan)

3.2.12 – Antioxidants and their standards (Butylated hydroxyanisole/dodecyl gallate/propyl gallate/octyl gallate/ascorbyl palmitate/sodium ascorbate/

- **3.2.13** Flavor enhancers and their standards (Monosodium glutamate)
- **3.2.14** Glazing agent (Mineral oil-Medium/low/high viscosity
- **3.2.15** Humectant/Wetting Agent/Dispersing Agent and their standards (Propylene glycol)
- 3.2.16 Sweetener/Humectant/Sequestrant and their standards (Sorbitol)
