#### **Report Highlights:**

This report focuses on the food and agricultural export certificates required by the Government of Kenya for U.S. agricultural commodities and product shipment to Kenya. FAS/Nairobi presents the information in a matrix format with specific examples of the required documentation in this report's appendix.

The Government of Kenya (GOK) protects "sensitive" agricultural products including meat/poultry, dairy and sugar products using high ad-valorem tariffs and non-tariff barriers such as the non-science based export certificates presented in this report.

#### Section II. Purpose of Specific Export Certificate(s)

#### Section III. Specific Attestations Required on Export Certificate(s)

All imported plant material must come under the plant import permit (PIP) issued by KEPHIS. The PIP requires that the following attestations disclose that the:

- Grain has been fumigated using appropriate fumigant before dispatch;
- Moisture content does not exceed 13.5 percent; and
- Status of genetic modification for corn and soybeans/meals. The attestation must come from USDA/FGIS or some other competent authority.

To import U.S. bovine semen, Kenyan importers must get an import permit from the Department of Veterinary Services, Ministry of Livestock Development. See appendix 14 for semen import requirements.
