New Controls Applied to Imported Food Products

Report Highlights:

This report lists all food and agricultural products subject to border inspection by commodity HS Codes. This regulation was adopted in April of 2018 and spells-out provisions of the Law of Ukraine "On State Control and Enforcement of Legislation on Safety of Food, Feeds, Animal Byproducts and Animal Health and Welfare." By this regulation, Ukraine imposes additional controls on composite products that contain small amounts of ingredient(s) of animal origin.

The Office of Agricultural Affairs of the USDA/Foreign Agricultural Service in Kyiv, Ukraine prepared this report for U.S. exporters of domestic food and agricultural products. While every possible care was taken in the preparation of this report, information provided may not be completely accurate either because policies have changed since its preparation, or because clear and consistent information about these policies was not available. It is highly recommended that U.S. exporters verify the full set of import requirements with their foreign customers who are normally best equipped to research such matters and specifics with local authorities before any goods are shipped.

Adoption of the List of Products Subject to State Control at Border Inspection Posts

To implement the Law of Ukraine "On State Control and Enforcement of Legislation on Safety of Food, Feeds, Animal Byproducts and Animal Health and Welfare" the Ministry of Agricultural Policy and Food of Ukraine adopted the list of products subject to state border control by <u>Order 159</u> adopted on March 26, 2018. This GAIN Report lists all agricultural and food products subject to such control (HS 1-24). All products listed below are subject to various types of control at Border Inspection Posts (BIPs).

At the time when this report was drafted the Cabinet of Minister's adopted <u>Resolution #960</u> (in Ukrainian) on application of veterinary, phytosanitary and food safety control on imported agricultural and food products. FAIRS subject report on this new regulation will be submitted separately.

By publication of this list, Ukraine introduced multiple additional controls over composite

products. Definition of composite products is laid out in Part 11 of Article 41 of the law of Ukraine "On State Control and Enforcement of Legislation on Safety of Food, Feeds, Animal Byproducts and Animal Health and Welfare."

A composite product is a product that satisfies the following conditions simultaneously:

- 1. The product does not contain meat components;
- 2. The product contains less than half of processed milk product and the product is shelf-stable at an ambient temperature or has undergone during its manufacture a complete cooking or heat treatment process throughout its substance, so that any raw product is denatured; the product is produced from processed fish or egg product;
- 3. The product is securely packaged or sealed in clean containers; and
- 4. The product is labeled in Ukrainian language and is accompanied by a document that in its entirety provides information as to category/type of composite food product, country of origin, producer, ingredients, and size and number of packages of the composite food product.

Although U.S. processed food exports to Ukraine are limited, of the U.S. processed food exports many

may be subject to new border inspections. The list includes, but is not limited to, frozen pizza, noodles, pasta with different stuffing and/or toppings, quiche pies, selected food supplements, frozen wraps, soups, broths, kefirs, yogurts and many others. The list includes multiple detailed definitions and special clauses that cover a variety of food products routinely imported from the EU countries.
